



2009 T.S.Q.H.A. FUTURITY RULES

September 19 & 20, 2009

Westmoreland Fairgrounds

ALL nominations and late fees will be paid out in full (excluding a \$15.00 office charge per entry). Prize monies will be paid to current owner to a maximum of ten places.

- 1. Membership-** All owners, part owners, and exhibitors participating in this futurity must be a paid up current year member of TSQHA & AQHA. TSQHA Membership dues must be paid with a separate check made payable to: TSQHA, C/O Jennifer Steele, 111 Concord Street, Indiana, PA 15701. [Click here for membership form.](#)
- 2. Futurity Entries:** - \$75.00 before June 30, 2009 or \$100.00 July 1, 2009 to August 31, 2009, Or \$150.00 September 1, 2009 until show date. [Click here for Futurity entry form.](#)
- 3.** Copies of horse(s) registration papers, Breeders Certificate (acceptable for weanlings) and AQHA cards must be presented when futurity numbers are picked up. **No exceptions.**
- 4.** Birth date and sex of foal **MUST** be sent to the Futurity Chairperson **BEFORE** final payment will be accepted.
- 5.** A member may nominate as many entries as desired. No substitutions or replacements permitted. Postmark denotes payment date (not postage meter)
NO POST DATED CHECKS WILL BE ACCEPTED
All entry payments are non-refundable
- 6. All futurity classes will show to both judges.** The Halter and Non Pro classes will be shown on Saturday September 19th and Open classes will be shown on Sunday September 20th.
- 7.** The combined score of the two judges will determine the winners of each class. **In the event of a tie, the tie will be broken for ribbons only and money the will be split evenly.** The tie-breaking judge will be determined by a coin flip prior to the start of the show.
- 8.** All classes will be held regardless of number of entries
- 9.** Transfer of ownership does not affect eligibility provided the Futurity Chairperson is notified in writing and new owner(s) become a TSQHA & AQHA member before horse(s) can be shown.
- 10.** Horse(s) need not be previously nominated in prior years for eligibility.
- 11.** Where general provisions are provided herein, AQHA rules will govern.
- 12.** Futurity checks for placing horses may be picked up the day of the show, if entries were postmarked before September 15, 2009.
- 13.** Proof of payment is the sole responsibility of the owner/exhibitor if discrepancy arises
